

- 7. Install in accordance with the manufacturer's instructions.

- 9. Do not defeat the safety purpose of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. QUICK START GUIDE

Once you have installed your PG-P Plus Type 1 where you need it, plug it in to an appropriate power source. If you are not sure your source is correct, consult with your local power company.

Plug in your equipment to the PG-P Plus Type 1.

Turn on the power. Enjoy filtered power!

- USB Chargers: 5V1A convenience chargers for USB devices; USB-A and USB-C
- Filtered Outlets: These outlets employ the PG-P Plus power filtering.
- ON/OFF Switch: Once the PG-P
 Plus Type 1 is plugged into a
 grounded 220-240VAC outlet,
 turning the POWER switch to the
 ON position will power the components plugged into all outlets.
- Voltage Meter: Three-character LED displays the line voltage at the source.
- 5. Ground OK: When this is on, the PG-P Plus Type 1 is plugged into a properly grounded power source. If the LED is not on, unplug the unit from the power source and correct the fault.
- 6. Protection ON: When this LED is on, the PG-P Plus Type 1 power surge circuitry is functioning correctly. If this LED is OFF, the circuit has malfunctioned. If it is OFF, unplug the unit immediately.
- Clean Power On: This LED indicates that the PG-P Plus Type 1 is providing clean, beautiful AC power to all connected components.
- Ultra-high Current AC Power
 Cable: integral high power, heavy
 duty AC cable to maximize power
 transfer to high current components such as amplifiers.
